Dear Year 12/13/14 Students and Parents or Carers,

I am thinking of you as you continue to work at home, and I hope that you and your families are keeping well. As we approach Half Term, I wanted to give you an update on how Qualifications will be awarded.

CCEA EXAM-BASED QUALIFICATIONS

Last week I texted a weblink to DENI's Factsheet for Parents and Students regarding CCEA's Alternative Awarding Arrangements for Summer 2021. The main points from CCEA are:

- All GCSE, AS and A Level CCEA examinations are cancelled and a student's grade in each CCEA exam-based qualification will be based on their school's professional assessment of the evidenced standard at which the student is performing in the content they have covered. These will be known as Centre Determined Grades.
- Students will continue with as much of their education as possible during this academic year. It is important that all students continue to engage with their learning and produce evidence of their best work.
- The range of evidence used to inform the Centre Determined Grade may be from any time during the course but must demonstrate knowledge, understanding and skills from areas covered within the specification.
- Evidence may include the student's performance in class assessments and mock exams, practical exams, controlled assessment or coursework or any other work completed (e.g. practice exam questions/essays).

CCEA OCCUPATIONAL STUDIES / OTHER EXAM BOARDS (i.e. Pearson BTEC, OCN, ASDAN, AQA)

More information is to follow from CCEA in March, relating to the awarding of Occupational Studies qualifications. It is highly likely this will follow the procedures listed above for exam-based qualifications. When we receive this information, we will forward this to you. Other Exam Boards are still to confirm how their qualifications will be awarded. However, as with CCEA, the focus will be on student evidence.

STUDENT EVIDENCE PORTFOLIOS

Student Evidence Portfolios are now vital in each subject. From February to April 2021, teachers will be finalising Student Evidence Portfolios, which will be used to decide upon Centre Determined Grades for all students. Teachers already have evidence in Student Evidence Portfolios, made up of work and assessments that students have completed during their course (most recently, the October and December 2020 Tracking Assessments), however, it is essential that students now use their time wisely in February through to April to add more work to their personalised Student Evidence Portfolios in each subject.

STUDENT RESPONSIBILITY- ADD WORK TO YOUR STUDENT EVIDENCE PORTFOLIOS

It is the responsibility of each Year 12/13/14 student to add to their STUDENT EVIDENCE PORTFOLIOS in each subject, by following these steps and the Feb-April 2021 Schedule overleaf:

- 1. Engage in learning at home (via Google Classroom) or in school (when permitted by DENI), and follow all teacher instructions to ensure that work in personalised Student Evidence Portfolios in each subject is the best it can be.
- 2. Submit work (of best quality) to all subject teachers which can be added to Student Evidence Portfolios in each subject.
- 3. Revise for the Spring Tracking Assessments, due to take place in some subjects in April 2021.
